



AMENDMENT IN STANDARD OPERATING PROCEDURE (SOP) FOR E-CHALLAN SYSTEM

No.25/2020

In continuation to SOP No. 25/2020 issued vide No.12050-62/UT/P-4 dated 21.07.2020 regarding e-Challan system. Sub-clause 9 of SOP for e-Challan refer to "Recommendation for suspension of Driving License as per Motor Vehicle Act, 1988 as amended in 2019 and as per the direction issued by Hon'ble Supreme Court Committee on Road Safety". As per the provision for the commission of listed offences, police officer is empowered to seize the driving license held by such driver and forwarded it to the licensing authority for disqualification or revocation proceeding u/s 19. Whenever compounding fee is collected for the listed compoundable traffic offences, then original DL shall be seized and an acknowledgment slip shall be issued to the violator as per M.V. Act, 1988 as amended in 2019.

Further, as per Clause No. 9 of E-Challan System SOP, description of offence of Speeding ^{S.112 & 183 MV Act} is mentioned at Sr. No. 2 in the listed offences, the same is substituted with "Second or Subsequent Speeding ^{S.112 & 183 MV Act},"

Accordingly, the Amendment in SOP is executed as under:-
